AUCTION NOTICE FOR DISPOSAL OF Cows

1. ICAR-Central Institute Freshwater Aquaculture on behalf of RRC Bangalore hereby invites sealed bids in the prescribed format (Annexure-I) for the Auction Cows, on "As is, Where is basis" at ICAR-CIFA, RRC Bangalore.
2. The interested Bidders may visit the premises of ICAR-CIFA, RRC Bangalore to inspect the Cows Physically offered for Disposal, on "As is, Where is basis" on any working day during 11.00 AM to 4.00 PM, before the Last Date of submission of sealed Bids.
3. The submission of quotation is fixed on 23.07.2019 (12.00 PM.). The quotation as per prescribed format at Annexures along with the ID proof, Aadhar, PAN, DL. The bidders should submit the tender with all enclosures at the tender box kept inside the Office. The bids received shall be opened in the presence of Authorized Committee on the same day i.e. 23.07.2019 (12.30 PM.). The vendors may participate in the bids opening as scheduled.
4. Bid security/EMD worth Rs. 4,000/- (Rupees Four thousand only) refundable shall be deposited by the vendors along with quotation in shape of Demand Draft in favour of "ICAR unit CIFA", SBI, Kausalyaganga code No. 8874. The EMD of the unsuccessful bidder / vendors shall be refunded on spot. The successful Bidder has the option / liberty to adjust the value of EMD with the full bid value offered and accepted by this Office.
5. Submission of quotation without EMD shall be treated as unresponsive and cancelled.
6. The successful Bidder has to deposit the balance of the Bid value in the same day or next working days in shape of Demand Draft / RTGS mode only to the undersigned.
7. On closure of the auction process the result will be declared / announced immediately on the stroke of hammer. On acceptance of the highest bid by this Office the vendor has to deposit the full Bid value on intimation by this Office.
8. **The highest bidder will have to supply self-attested photocopy of his identity proof (Aadhar/Ration Card/PAN card/Driving license / Electricity bill/Voter card / UID etc.). The bidder will be responsible for lifting the animals within 24 hours / Next working day and in case they fail** to do so a sum of Rs. 400/- (Rupees Four hundred only) per day per animal will be charged from them as feeding / maintenance charges. The sold animals are to be lifted at the earliest failing which the whole amount paid for the purchase will stand forfeited.
9. The lifting / transportation charges etc. will be borne by the successful bidder/vendor.
10. The vendor/bidder should take precautionary measures for the safety of the workers while lifting / transporting of Cows. This Office will not take any responsibility in this regard.
11. After the auction is over and award of contract is made to the highest bidder the security of the material is at the bidder's risk. The institute is not liable for any loss/ theft/ damaged of the auction items.
12. No negotiation as per rule is permissible.
13. If any bidder does not follow the instructions of ICAR-CIFA, Officials or create any type of nuisance, then he can be disallowed to participate in bidding and can be asked to leave the venue immediately or legal action will be taken against him/them as deemed fit by this Office.
14. Bids received after the specified schedule date and time, the quotation shall not be considered and the same will be refunded as such on spot to the vendor.
