Bids received without any one of the above documents will be rejected. Post/by directly be dropped in the tender box kept in Director Cell, ICAR CIFA on or before last date and time for submission of bid duly superscribing Quotation for Disposal of Chakunda Trees at ICAR CIFA.
 5. The Security Deposit of Rs. 5,000/- (Rupees Five thousand only) shall be forfeited if:
 - (a) The successful Bidder fails to deposit 1/3rd of auction amount on the spot / same day.
 - (b) The successful Bidder fails to make complete payment along with GST amount within the stipulated time.
 - (c) The successful Bidder fails to take away the whole auctioned items on his own arrangement on or before the last date.
 6. Participation in the auction for part of the items is not allowed.
 7. The amount of Security Deposit deposited shall be adjusted from the total amount of payment due from the successful bidder.
