- 3. The interested Bidders may visit the premises of ICAR-CIFA, Kausalyaganga, Bhubaneswar-751002 to inspect the items offered for disposal, on "As is Where is basis" on any working day during 11.00 AM to 4.00 PM, before the Last Date of submission of sealed Disposal-Bids.
- 4. The submission of quotation is fixed up to 15.01.2022 (3.00 PM.). The quotation received shall be opened in the presence of Authorized Committee on the next day i.e. 16.01.2022 at 11.00 AM. The vendors may participate by depositing Rs.500/- as participation fee (non-refundable) drawn in shape of Demand Draft in favour of ICAR Unit-CIFA, SBI. Kausalyaganga, Code No. 8874 in the bid opening as scheduled.
- 5. Bid Security (EMD)(not less than twenty-five percent of the bid value) shall be taken on the spot from the successful bidder either in cash or in the form of Deposit-at-Call-Receipt(DACR) drawn in favour of ICAR-Unit, CIFA, SBI,Kausalyaganga code No.8874.

- 14. In case the total quantity is to be disposed of cannot be lifted / taken away by the highest acceptable bidder (L1). The next highest bidder (L, 2) shall be given offer to accept the price of L1 bidder. If agreed, the scope will be given to take up the materials on deposit of bid value.
