ICAR-Central Institute of Freshwater Aquaculture, Kausalyaganga, Bhubaneswar, Odisha (<http://cifa.nic.in>) invites application from the interested candidates to undertake **6 (SIX)** months research work for their M.Sc./PG study at ICAR-CIFA, Kausalyaganga.

The Institute will consider the application of those students from the Universities, Institutions where there exists **(1)** a Memorandum of Understanding (MoU) between the ICAR-CIFA and the said Institute/University **(2)** the candidate is willing to pay **Rs. 30,000/** (Rupees thirty thousand)- for six-month research work as the bench/Institution fee of the ICAR-CIFA. However, those students who are from the Institutions/Universities under the NARS (National Agriculture Research System) (Ex. OUAT, Bhubaneswar) are exempted to pay the requisite fees of Rs. 30,000/-.

Hence, for the academic year 2024-25 the selection would be completely on merit basis where the cut-off mark will be maintained as minimum 65% (cumulative average percentage of 10th, Diploma/10+2 and B.Sc.) or 6.5 OGPA/10 scale.

The acceptability of the total number of students will depend on the intake capacity of the ICAR-CIFA at the time of his/her application, and it will entirely depend on the decision of the competent authority.
